7) In View of the above, RENEWAL OF FIRE NO OBJECTION CERTIFICATE for the above said building is issued subject to the following Conditions:

1. The NOC issued is confined to the Fire Safety measures installed in the building and does not confer any Legal right for claiming of Ownership of property or Conversion of land use / Occupancy or Building Regularization. The Owner / Occupier shall comply the Building Rules / Govt Orders as applicable.
2. Fixed and first-aid Fire Fighting equipment, alarm etc shall be tested and maintained regularly as per applicable standards and Fire-Drills conducted quarterly for first two years and half yearly after two Years.
3. No temporary structure such as tents or with thatched construction should be allowed for educational institutions.
4. Emergency power generator etc., and associated equipment should be tested periodically, verified as per NBC, and IS-1646.
5. The Management is to provide 10,000 Ltrs Water Tank with RCC Construction at the terrace level within 03 months (or) Otherwise connect to Terrace Tank already available.
6. Every room with a capacity of 45 students shall be maintained obstruction free minimum two doorways.
7. Every vertical opening between at the floors shall be suitably enclosed or protected, with ventilation System by ducts and Balconies.
8. The Builder / Occupier should facilitate periodical inspection by jurisdiction Station Fire Officer and District Fire Officer, Fire Prevention Wing, GHMC, Hyderabad.
9. Evacuation plan at showing exit routes and recommended action plan be displayed at conspicuous locations and shall be exhibited all times, all escape / exit routes shall not be blocked or encroached.
10. Fresh NOC would be required for any change in occupancy or additions/alterations in the building structure as per NBC of India and building bye/laws.
11. The Management has to maintain Fire Safety Measures at all times in good working Condition as seen during the inspection.
12. Any Loss of life or property due to Non - functioning of Fire Safety Measures and other installations shall be the responsibility of the management/owner.
13. All the Occupants must know the correct method of operation of the Fire Fighting System installed.

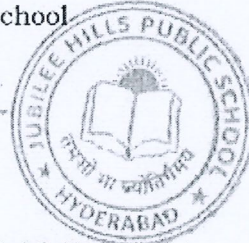

**ORDER:**

Hon'ble Supreme Court of India in its Judgment dated:13.04.2009 in W.P. No.483 of 2004 have issued the following directions keeping in view of the Safety and Security of School going children which has utmost importance:

"It has become imperative to direct that, Safety Measures as prescribed by the National Building Code of India, 2005 be implemented by all Government and Private Schools functioning in our Country.

- (i) Before Granting recognition or affiliation, the concerned State Government and Union Territories are directed to ensure that the buildings are safe and secure from every angle and they are constructed according to the safety norms incorporated in the National Building Code of India.
  - (ii) All Existing Government and Private Schools shall install fire extinguishing equipment within a period of Six Months.
  - (iii) The School Buildings be kept free from inflammable and toxic material. If storage is inevitable, they should be stored safely.
  - (iv) Evaluation of structure aspect of the school may be carried out periodically. We direct that the concerned engineers and officials must strictly follow the National Building Code. The Safety Certificate be issued only after proper inspection. Dereliction in duty must attract immediate disciplinary action against the concerned officials.
  - (v) Necessary training be imparted to the staff and other officials of the school to use the Fire extinguishing equipment".
2. The Director General of State Disaster Response & Fire Services, Telangana, Hyderabad in his letter 4<sup>th</sup> read above has requested the Government to constitute an Expert Committee on Setbacks and Retrofitting of Fire Safety Installations in the

Accordingly, Government have constituted the Expert Committee with the following Members to suggest norms for different Educational institutions existing prior to the order of the Hon'ble Supreme Court Judgment and also to suggest standard norms applicable for such institutions regarding setbacks and retrofitting of the Fire Safety Installations in the existing School buildings vide G.O. 5<sup>th</sup> read above:

4. The Expert Committee has submitted its report with specific recommendations the Director General, TSDR & FS has submitted the recommendations to the Government vide letter 6<sup>th</sup> read above.

5. Subsequently, the Chief Secretary to Government has convened a meeting with all the concerned on 12.06.2019 on the fire safety issues in schools and decided to issue guidelines on the issues of Fire Safety in the Schools. The Director General, Telangana State Disaster Response & Fire Services Department has also furnished his remarks to Government vide letter 8<sup>th</sup> read above.

✓ 6. Government after careful consideration of the decisions taken in the meeting convened by the Chief Secretary to Government on 12.06.2019 and also further remarks of the Director General, Telangana State Disaster Response & Fire Services Department and in compliance of the directions of the Hon'ble Supreme Court of India in its Judgement dated:13.04.2009 in W.P. No.483 of 2004, here by order that, all Schools existing before the Hon'ble Supreme Court Order i.e., dated:13.04.2009, shall follow the Fire Safety norms as recommended by the Expert Committee as detailed in the Annexure-I appended to this order, for the purpose of obtaining the affiliation/recognition. Further Self Certification forms shall be submitted by the Schools for the purpose of affiliation/recognition to the Authority concerned of Education Department, in the proforma prescribed at Annexure-I appended, duly marking a copy to the jurisdictional Divisional Fire Officer. The Officers of Telangana State Disaster Response & Fire Service will conduct surprise inspections randomly and if any deviations from Self Certification forms are noticed, the same will be intimated to the concerned authority of Education Department recommending for the cancellation of the affiliation/recognition.

7. Further, all Schools constructed after the Hon'ble Supreme Court Order dated:13.04.2009 shall follow the Safety norms of National Building Code of India. The Telangana State Disaster Response & Fire Services Department will Issue Fire No Objection Certificate (NOC) for those schools which come within the purview of Section 13 (1) of Telangana Fire Service Act 1999, that is, Schools which more than 500 Sq.Mtrs in Plot area or 6 Mtrs and above in height duly following the norms of National Building Code of India.

8. All other schools constructed after the Hon'ble Supreme Court order dated:13.04.2009 and which do not come within the purview of the Telangana Fire Service Act, 1999 shall submit self certification forms in the proforma prescribed at Annexure-II appended to this order, to the concerned Authority of the Education Department for the purpose of affiliation/recognition by the Education Department duly marking a copy to the jurisdictional Divisional Fire Officer. The Officers of Telangana State Disaster Response & Fire Service will conduct surprise inspections


